MEIKO USA, Inc. ORIGINAL EQUIPMENT WARRANTY

MEIKO USA, INC. WARE WASHING EQUIPMENT IS WARRANTED TO THE ORIGINAL PURCHASER TO BE FREE FROM DEFECTS IN MATERIAL OR WORKMANSHIP FOR A PERIOD OF ONE (1) YEAR FROM THE DATE OF INSTALLATION, OR EIGHTEEN (18) MONTHS FROM THE DATE OF PURCHASE, WHICHEVER IS EARLIER.

Meiko USA, Inc. agrees to repair or replace at its discretion, any original part which fails under normal use due to faulty material or workmanship during the warranty period specified above, providing the equipment has been properly installed, maintained and operated in accordance with the applicable factory literature provided with this equipment and the failure is reported to Meiko's factory authorized Service Agent within the specified warranty period. The cost of replacement parts and the labor to replace such parts as well as associated travel charges within the contiguous 48 United States, Alaska and Hawaii, will be paid directly to Meiko's authorized Service Agent by Meiko USA, Inc. Work performed by any person or agency not authorized by the factory, or the performance of, or damage caused by any non-genuine replacement part or accessory is the sole responsibility of the customer.

Accessory components such as table limit switches, pressure regulators, pre-rinse units, etc. that are shipped with the unit and not installed by the factory carry a one (1) year parts warranty only.

This warranty is void if a failure is a direct result of shipping, handling, fire, freezing, water damage (flood) accident, misuse, acts of God, attempted repair by unauthorized persons, improper installation or the use of non-genuine (generic) replacement parts.

TRAVEL LIMITATIONS

Meiko USA, Inc. limits warranty travel time to two (2) hours and mileage to one hundred (100) miles (160 KM). Meiko USA, Inc. will not pay for travel expenses in excess of these limits or for any other associated travel expense without prior authorization from the factory.

REPLACEMENT PARTS WARRANTY

Meiko USA, Inc. genuine replacement parts are warranted for a period of ninety (90) days from the date of installation by Meiko USA, Inc.'s Authorized Service Agent, or for the balance of the original one (1) year warranty, whichever is less.

WARRANTY VALIDATION

This warranty becomes valid upon completion of the New Equipment Performance and Installation Inspection by our Meiko USA, Inc.'s Authorized Service Agent. It is the responsibility of the customer to contact the local Authorized Service Agency to arrange this free inspection.

THIS IS MEIKO USA, INC.'S ENTIRE AND ONLY WARRANTY AND SUPERCEDES ALL OTHER WARRANTIES, WRITTEN OR IMPLIED. MEIKO USA, INC.'S LIABILITY FOR ANY CLAIM OF ANY KIND, INCLUDING BUT NOT LIMITED TO NEGLIGENCE WITH RESPECT TO THE GOODS OR SERVICES COVERED HEREUNDER SHALL IN NO CASE EXCEED THE PRICE OF THE GOODS AND SERVICES OR PART THEREOF WHICH GIVES RISE TO THE CLAIM.

THERE ARE NO WARRANTIES, EXPRESSED OR IMPLIED, INCLUDING FOR FITNESS OR MERCHANTABILITY, THAT ARE NOT SET FORTH HEREIN, OR THAT EXTEND BEYOND THE DURATION HEREOF. UNO CIRCUMSTANCES WILL MEIKO USA, INC. BE LIABLE FOR ANY LOSS OR DAMAGE, DIRECT OR CONSEQUENTIAL, OR FOR THE DAMAGES IN THE NATURE OF PENALTIES, ARISING OUT OF THE USE OR INABILITY TO USE ANY OF ITS PRODUCTS.
